- a. SLHS Marketing students developed Friends of Southgate Community Center logos for the board to consider. IV. Public Art Reston Presentation – (Ann Delaney)

- a. This non profit organization commissions art work in Reston as a way to decrease vandalism or eliminate graffiti in our public space – specifically underpasses. This group is responsible for the artwork on Glade Drive underpass (2010). They are proposing two sites for public artwork – 1. Pinecrest Road Underpass and 2. Colts Neck Drive Underpass.
- b. They are reaching out to us to help with financing the project. The proposed budget is \$40k - \$50k. The budget timeline is March – June 30,2018. They have received contributions from ACFC Project Grant \$9,450 – Public Art Reston \$10k – Private contributions \$2,500. They need to raise an additional \$18k - \$28k and they are seeking our assistance with identifying potential sponsors and artists.
